100 g APESIN DSR 50 contain 12 g citric acid, 9 g phosphoric acid, less than 5% anionic surfactants. Other ingredients: perfume oil and colors. pH approx. 1.

Activity:

Range of application:

Directions for use:

Remove coarse, encrusted dirt by mechanical means.
