Henkel, headquartered in Düsseldorf / Germany, has about 52,000 employees worldwide and counts among the most internationally aligned Germanbased companies in the global market place

History of Henkel in Greece

From 1968 to 1989, Henkel products were distributed in the Greek market via licensees. The Greek owned company "T.Trifon & P. Kastrinis S.A." launched Dixan in 1968, Persil in 1970 and Fa and Polykur in 1981. In 1974, Henkel Chemical S.A. launched Adhesives and Technology products.

1989 Henkel KGaA bought 57% of the stocks of the Greek owned company "T.Trifon & P. Kastrinis S.A."

The company was renamed to Henkel Hellas S.A.

1991 Henkel KGaA bought another 31% of Henkel Hellas S.A.
 Henkel KGaA acquired Henkel Chemical S.A.

2006 Started the liquidation of Schwarzkopf & Rilken S.A.

Consolidated the warehouses of the Henkel Hellas group of companies in the new center of warehousing and Distribution in Mandra, Attikis.

The company's head offices and a production plant of Industrial Adhesives are located in Athens, while there is also a Branch Office located in Thessaloniki.

Rilken S.A operates within the Cosmetics / Toiletries business sector, Professional and Retail, respectively. The company is located in Athens, while there is one branch office in Thessaloniki, where the Schwarzkopf Professional Academy is also located.


Rilken S.A. is a Company listed in the Greek stock exchange market.

As of December 2006, 340 people work for Henkel Group of Companies in Greece, the majority of which are employed in Athens.


Even though the Henkel name is relatively new in the Greek market, the Company, with its successful brand names, as well as its competitive position, is an attractive employer in Greece.

2006 turnover by business sector





2006 EBIT by business sector
